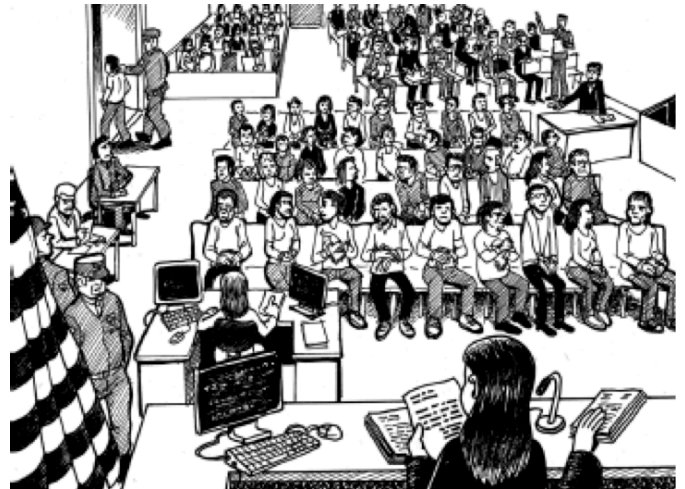


END STREAMLINE COALITION WANTS YOU TO TAKE ACTION!!



GO TO OPERATION STREAMLINE

- Operation Streamline takes place Monday through Friday at 1:30pm on the second floor of the DeConcini Federal Courthouse, 405 W Congress, Tucson, AZ. Hearings are open to the public and last about two hours.
- Bring a government-issued photo ID.
- You may download the list of defendants on the morning of the hearing you plan to attend. Go to www.azd.uscourts.gov. Under Calendars, select “Tucson Operation Streamline Calendar.” You may print and bring the list with you into court that day.
